## State Legislative Elected Officials Representing Seminole County Residents

The state Constitutional office of **County Tax Collector** is one of five independent **administrative state officers** serving the citizens of Seminole County to provide specific responsibilities referenced in the Florida Constitution, with added services as created by the State Legislature from time to time through the Florida Statutes.

The Florida Tax Collectors **are not responsible** for state legislation, such as determining annual statutory rate fees. The Constitutional Office of the Tax Collector is the ombudsmen for Seminole County residents, while serving locally on behalf of various Florida state agencies, such as the Department of Highway Safety and Motor Vehicles, the Fish and Wildlife Conservation Commission, and the Department of Revenue.

As a Seminole County and state of Florida resident, it is your responsibility to communicate with your legislators on all matters important to you. Should you wish to express an opinion, you will find the name, address, and telephone number for the Governor and all of the legislators representing Seminole County residents listed below. If you are unsure of your particular Senate or House District, you can go to the web address provided and find the name of your individual Senator and Representative.
